Tasks of the RTA assistant:

- Acting as interpreter and translator Croatian, English, German on any issues relevant to the project, especially during seminars and workshops in and outside of Zagreb;

- Assisting RTA in organization of experts' missions, trainings, seminars, workshops, steering committee meetings, and other project events;
