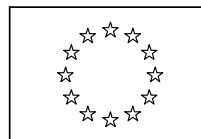


Local publication for call for proposals

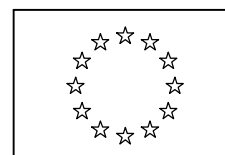
