5. **Contracting authority:**

Central Finance and Contracting Agency, Zagreb, REPUBLIC OF CROATIA.

6. **Nature of contract:**

Fee-based.

7. **Contract description:**

Simultaneously with the implementation of the regional competitiveness operational programme (RCOP) financed by IPA funding, Croatian authorities are in charge of programming a new operational programme that will be financed through Structural Funds in the period 2014–2020.

The purpose of this project is twofold:

First, the project will provide assistance to the Croatian authorities in preparation of the operational programme (OP) for the programming period 2014–2020 which is an extensive assistance from initial analysis to development of the final OP.

The second component of the project refers to assistance in preparation of a number of strategically selected infrastructure projects and national projects identified under the Structural Funds RCOP pipeline. This will cover substantial coaching and training of the applicants in the form of the transfer of methodologies and best practices in project preparation which will enable them to successfully prepare all the documents that are needed in order to apply for and receive the European Regional Development Fund (ERDF) funding.

The project also includes activities of raising awareness on ERDF funding opportunities.

8. **Numbers and titles of lots:**

The contract is divided into lots: No, 1 lot only.

9. **Budget:**

Maximum budget: 2 800 000 EUR.

10. **Scope for additional services:**

The contracting authority may, at its own discretion, extend the project in duration and/or scope, subject to the availability of funding, up to a maximum not exceeding the length and value of the initial contract. Any extension of the contract would be subject to satisfactory performance by the contractor.

Conditions of participation

11. **Eligibility:**

Participation is open to all legal persons (participating either individually or in a grouping (consortium) of candidates) which are established in a Member State of the European Union or in a country or territory of the regions covered and/or authorised by the specific instruments applicable to the programme under which the contract is financed (see also item 29 below). Participation is also open to international organisations. The participation of natural persons is governed by the specific instruments applicable to the programme under which the contract is financed.

12. **Candidature:**

All eligible natural and legal persons (as per item 11 above) or groupings of such persons (consortia) may apply.

A consortium may be a permanent, legally-established grouping or a grouping which has been constituted informally for a specific tender procedure. All members of a consortium (i.e., the leader and all other members) are jointly and severally liable to the contracting authority.

The participation of an ineligible natural or legal person (as per item 11) will result in the automatic exclusion of that person. In particular, if that ineligible person belongs to a consortium, the whole consortium will be excluded.

13. **Number of applications:**

No more than 1 application can be submitted by a natural or legal person whatever the form of participation (as an individual legal entity or as leader or member of a consortium submitting an application). In the event that a natural or legal person submits more than 1 application, all applications in which that person has participated will be excluded.

14. **Shortlist alliances prohibited:**

Any tenders received from tenderers having a different composition than the ones on the application forms will be excluded from this restricted tender procedure, unless prior approval from the contracting authority has been obtained — see PRAG 2.4.3. Shortlisted candidates may not form alliances or subcontract to each other for the contract in question.

15. **Grounds for exclusion:**

As part of the application form, candidates must submit a signed declaration, included in the standard application form, to the effect that they are not in any of the exclusion situations listed in Section 2.3.3 of the 'Practical Guide to contract procedures for EU external actions'.

16. **Subcontracting:**

Subcontracting is not allowed.

17. **Number of candidates to be shortlisted:**

On the basis of the applications received, at least 4 and at most 8 candidates will be invited to submit detailed tenders for this contract. If the number of eligible candidates meeting the selection criteria is less than the minimum of 4, the contracting authority may invite the candidates who satisfy the criteria to submit a tender.

Selection and award criteria

21. **Selection criteria:**
Same criteria for legal and natural person.
The following selection criteria will be applied to candidates. In the case of applications submitted by a consortium, these selection criteria will be applied to the consortium as a whole:
- 1) Economic and financial capacity of candidate:
In the case of the applicant being a public body equivalent information should be provided:
 1. the average annual turnover of the candidate for the years 2009, 2010 and 2011 must have been equal to or exceeded 1 400 000 EUR (2009 is considered to be 2 years before last year, 2010 is considered to be the year before last and 2011 is considered to be last year);
 2. the averages of cash and cash equivalents at the end of 2009, 2010 and 2011 are positive.
 - 2) Professional capacity of candidate:
 1. at least 5 staff currently work for the applicant in fields (programming of multiannual development programmes in the public sector and preparation of a project pipeline in competitiveness sector) related to this contract and are permanent.
 - 3) Technical capacity of candidate:
 1. the candidate completed at least 1 technical assistance project (contracted as 1 single contract) covering the following fields: programming of multiannual development programmes in the public sector and preparation of a project pipeline in competitiveness sector. The project(s) must have been completed in the years 2009, 2010, 2011 or 2012 (until the deadline for receipt of applications). Both fields can be covered by 1 single project or by separate projects;
 2. the project must have been implemented in one of the IPA eligible countries according to the Council Regulation (EC) 1085/2006, OJ 210/82;
 3. the project(s) must have been with a budget (own contribution) equal to or exceeding 2 000 000 EUR. In case the abovementioned fields (programming of multiannual development programmes in the public sector and preparation of a project pipeline in competitiveness sector) are covered by separate projects only 1 of the projects must have been with a budget (own contribution) equal to or exceeding the established amount of 2 000 000 EUR.
- An economic operator may, where appropriate and for a particular contract, rely on the capacities of other entities, regardless of the legal nature of the links which it has with them. Some examples of when it may not be considered appropriate by the contracting authority are when the tenderers rely in majority on the capacities of other entities or when they rely on key criteria. If the candidate relies on other entities it must in that case prove to the contracting authority that it will have at its disposal the resources necessary for performance of the contract, for example by producing an undertaking on the part of those entities to place those resources at its disposal. Such entities, for instance the parent company of the economic operator, must respect the same rules

of eligibility and notably that of nationality, as the economic operator. Furthermore, the data for this third entity for the relevant selection criterion should be included in the tender in a separate document. Proof of the capacity will also have to be furnished when requested by the contracting authority.

If more than 8 eligible candidates meet the above selection criteria, the relative strengths and weaknesses of the applications of these candidates must be re-examined to identify the 8 best applications for the tender procedure. The only factors which will be taken into consideration during this re-examination are:
the total number of projects managed by the candidate according to criterion 3;
in case of competition between 2 or more candidates having the same number of eligible projects, the candidates will be ranked in descending order according to the total amount of their own contribution to the eligible projects.

22. **Award criteria:**
Best value for money.

24. **Application format and details to be provided:**

Any additional documentation (brochure, letter, etc.) sent with an application will not be taken into consideration.
25. **How applications may be submitted:**
Applications must be submitted exclusively to the contracting authority in the following language: English — either by recorded delivery (official postal service) to:

The contract title and the publication reference (see item 1 above) must be clearly marked on the envelope containing the application and must always be mentioned in all subsequent correspondence with the contracting authority.
Applications submitted by any other means will not be considered.
26. **Alteration or withdrawal of applications:**
Candidates may alter or withdraw their applications by written notification prior to the deadline for submission of applications. No applications may be altered after this deadline.
Any such notification of alteration or withdrawal shall be prepared and submitted in accordance with item 25. The outer envelope (and the relevant inner envelope if used) must be marked 'Alteration' or 'Withdrawal' as appropriate.

All written communications for this tender procedure and contract must be in English.
