Central Finance and Contracting Agency, Zagreb, REPUBLIC OF CROATIA.

6. **Nature of contract:**

Fee-based.

7. **Contract description:**

The project is designed to increase the compliance level of the Central Bureau of Statistics (CBS) with the EU 'acquis' in the following priority areas:

— further development of business statistics with sub-projects on energy statistics, short-term statistics, modernisation of business statistics surveys (MEETS) and information society statistics (ISSs),

— upgrading of the existing data collection system.

These statistical domains are considered priorities both by the Central Bureau of Statistics of Croatia and by Eurostat.

The project will facilitate further alignment with the 'acquis communautaire' in the areas of business statistics, such as energy statistics in order to extend the scope of energy efficiency data (new survey on energy final consumption in the transport sector), additional developments in short-term statistics — STSs (new surveys concerning missing short-term indicators), technological modernisation of business statistical surveys with the

objective of increasing efficiency and reducing the administrative burden on enterprises, as well as a need to apply changes in the 'acquis communautaire' introduced in the ISSs.

Regarding the upgrading of the existing data collection system, due to the growing demand on increased cost-effectiveness of data collection activities, the aim of the project is to upgrade the existing computer-assisted interviewing (CAI) — computer-assisted personal interviewing (CAPI) and computer-assisted telephone interviewing (CATI).

8. **Numbers and titles of lots:**

The contract is divided into lots:  
No, 1 lot only.

9. **Budget:**

Maximum budget: 770 000 EUR.

10. **Scope for additional services:**

The contracting authority may, at its own discretion, extend the project in duration and/or scope, subject to the availability of funding, up to a maximum not exceeding the length and value of the initial contract. Any extension of the contract would be subject to satisfactory performance by the contractor.

**Conditions of participation**

11. **Eligibility:**

Participation is open to all legal persons (participating either individually or in a grouping (consortium) of candidates) which are established in a Member State of the European Union or in a country or territory of the regions covered and/or authorised by the specific instruments applicable to the programme under which the contract is financed (see also item 29 below). Participation is also open to international organisations. The participation of natural persons is governed by the specific instruments applicable to the programme under which the contract is financed.

12. **Candidature:**

All eligible natural and legal persons (as per item 11 above) or groupings of such persons (consortia) may apply.

A consortium may be a permanent, legally-established grouping or a grouping which has been constituted informally for a specific tender procedure. All members of a consortium (i.e., the leader and all other members) are jointly and severally liable to the contracting authority.

The participation of an ineligible natural or legal person (as per item 11) will result in the automatic exclusion of that person. In particular, if that ineligible person belongs to a consortium, the whole consortium will be excluded.

13. **Number of applications:**

No more than 1 application can be submitted by a natural or legal person whatever the form of participation (as an individual legal entity or as leader or member of a consortium submitting an application). In the event that a natural or legal person submits more than 1 application, all applications in which that person has participated will be excluded.

14. **Shortlist alliances prohibited:**

Any tenders received from tenderers having a different composition than the ones on the application forms will be excluded from this restricted tender procedure, unless prior approval from the contracting authority has been obtained — see PRAG 2.4.3. Shortlisted candidates may not form alliances or subcontract to each other for the contract in question.

15. **Grounds for exclusion:**

As part of the application form, candidates must submit a signed declaration, included in the standard application form, to the effect that they are not in any of the exclusion situations listed in Section 2.3.3 of the 'Practical Guide to contract procedures for EU external actions'.

16. **Subcontracting:**

Subcontracting is allowed.

Maximum percentage of the contract value which may be subcontracted: 7 %.

Activities which may be subcontracted: 1) Pilot surveys — in order to provide the necessary foundations for a sustainable system for production of statistics, each newly developed methodology shall be tested in practice.

17. **Number of candidates to be shortlisted:**

On the basis of the applications received, at least 4 and at most 8 candidates will be invited to submit detailed tenders for this contract. If the number of eligible candidates meeting the selection criteria is less than the minimum of 4, the contracting authority may invite the candidates who satisfy the criteria to submit a tender.

**Selection and award criteria**

21. **Selection criteria:**

Same criteria for legal and natural person.

The following selection criteria will be applied to candidates. In the case of applications submitted by a consortium, these selection criteria will be applied to the consortium as a whole:

1) Economic and financial capacity of candidate:

In the case of the applicant being a public body equivalent information should be provided:

1. the annual turnover of the candidate for the years 2009, 2010 and 2011 must have been equal to or exceeded 400 000 EUR (2009 is considered to be 2 years before last year, 2010 is considered to be a year before last and 2011 is considered to be last year);

2. the cash and cash equivalents of the candidate at the end of the years 2009, 2010 and 2011 were positive.

2) Professional capacity of candidate:

1. at least 5 staff currently work for the candidate in the field related to this contract (statistics) and are permanent.

3) Technical capacity of candidate:

1. the candidate has completed successfully at least 1 technical assistance project (contracted as 1 single contract) covering the field of statistics. The contract(s) must have been implemented within 3 years before the deadline for receipt of applications, as indicated in point 23 of this procurement notice;

2. project(s) must have been implemented in a country eligible under the IPA programme as per Council Regulation (EC) No 1085/2006;

3. at least 1 project must have been with a budget (own contribution) equal to or exceeding 770 000 EUR.

An economic operator may, where appropriate and for a particular contract, rely on the capacities of other entities, regardless of the legal nature of the links which it has with them. Some examples of when it may not be considered appropriate by the contracting authority are when the tenderers rely in majority on the capacities of other entities or when they rely on key criteria. If the candidate relies on other entities it must in that case

prove to the contracting authority that it will have at its disposal the resources necessary for performance of the contract, for example by producing an undertaking on the part of those entities to place those resources at its disposal. Such entities, for instance the parent company of the economic operator, must respect the same rules of eligibility and notably that of nationality, as the economic operator. Furthermore, the data for this third entity for the relevant selection criterion should be included in the tender in a separate document. Proof of the capacity will also have to be furnished when requested by the contracting authority.

If more than 8 eligible candidates meet the above selection criteria, the relative strengths and weaknesses of the applications of these candidates must be re-examined to identify the 8 best applications for the tender procedure. The only factors which will be taken into consideration during this re-examination are:

- 1) the total number of projects managed by the candidate according to criterion 3;
- 2) in case of competition between 2 or more candidates having the same number of eligible projects, the candidates will be ranked in descending order according to the total amount of their own contribution to the eligible projects.

22. **Award criteria:**  
Best value for money.

24. **Application format and details to be provided:**

Applications must be submitted using the standard application form, the format and instructions of which must be strictly observed. Any additional documentation (brochure, letter, etc.) sent with an application will not be taken into consideration.

25. **How applications may be submitted:**

Applications submitted by any other means will not be considered.

26. **Alteration or withdrawal of applications:**

Candidates may alter or withdraw their applications by written notification prior to the deadline for submission of applications. No applications may be altered after this deadline.

Any such notification of alteration or withdrawal shall be prepared and submitted in accordance with item 25.

The outer envelope (and the relevant inner envelope if used) must be marked 'Alteration' or 'Withdrawal' as appropriate.

All written communications for this tender procedure and contract must be in English.
